

Directions to trial site:

Hwy 75 or Dallas North Tollway to US 380. US 380 to Lake Forest Drive (FM 1461), North to County Road 166, right turn, and North again several hundred yards to Myers Park. Look for the signs, and see also:

Do not rely on GPS prompts. These have been noted to be unreliable in this area. It is recommended that you print a paper map to follow if you are unfamiliar with the local geography.

NOTE TO ALL EXHIBITORS

Per Barn Hunt Association rules, bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their classes. There will be a sign indicating the BIS Crating Area. Entry fees for bitches that come into season will be refunded until the closing date of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If you bring a bitch in season, you **must** inform the trial committee prior to the trial and you are requested to inform all exhibitors at the judges' briefings. Bitches in season must wear pants when running. Please also inform the trial secretary so your running order can be adjusted.

Open to all breeds and mixed breeds.

Entries open on 12/1/2018 and close on 1/16/2019. Day-of-Show Entries will be available if the event has not filled. Entries which arrive late will be processed as Day-of-Show upon payment of the Day-of-Show entry fee at the trial site, if the trial has not filled. Entry limits to be determined per Part 4, Section 5 of the Barn Hunt Rule Book. Load Balancing and/or assignment splitting may be done at this event.

Entry fees are \$18/run (Instinct, Novice, Open, and Crazy 8s) and \$25/run (Senior and Master) for pre-entry. Late or day of show entries: add \$5/run. Entry fees for the Team class (For Exhibition Only) are \$5 per dog per run; enter at the trial site.

Permission has been granted by the Barn Hunt Association, LLC
for the holding of these barn hunt trials under BHA Rules and Regulations.



Four trials offered; AM and PM, Saturday and Sunday

Classes offered each day: Instinct Test as the first class Saturday followed by Novice and Open in Ring 1. Senior and Master will run in Ring 2. The second trial of the day (which will **not** include Instinct but **will** include Crazy 8s) will begin after 11:00 AM. On Sunday, Crazy 8s will be the first class in Ring 1.

Team, a games class, will be run For Exhibition Only as time allows on Saturday only. See your email confirmation for more information.

Dogs must be eligible to run a class at time of entry. Dogs who complete a title at a trial may move up in the next trial. Please make move-up requests at the Trial Secretary's desk as soon as possible. Handlers are responsible for making the request in time for the move-up to be processed.

All entries must be accompanied by correct entry fees. Entries must have a Barn Hunt Association registration number. Forms submitted without a registration number will be returned. Any entries received before the opening date will be returned. A returned check does not constitute a valid entry and will incur a \$50 penalty. No electronic entries other than via Wufoo (see below) will be accepted. Send entries to the Trial Secretary and make checks payable to North Texas Barnhunters. **NOTE: entries sent to the trial site are not valid and will be returned or discarded. See the entry form for the correct address.**

Note: you may fill your entry form out online by clicking on "create mail in entry" at the event link on barnhunt.com. Be sure to click the "I understand" box and print your entry out (use the "print" button right under the box) before mailing it in.

Note that there is a \$5.00 service charge for using the Wufoo link, but you don't have to print anything or find a stamp. **We prefer entries via Wufoo or Barnhunt.com. Handwritten entries that are illegible may be rejected.**

A wait list will be maintained. Entrants who withdraw after the closing date will receive a refund only if there is an entrant on the wait list who can take their place.

EXHIBITOR INFORMATION

All dogs must be kept on a short leash and under control while on trial grounds except when showing. Electronic collars and head halters are not permitted. No dog may be at any time tied out or otherwise attached to anything other than a human. There is no smoking allowed inside the building, and no alcohol allowed anywhere at the facility. **Handlers who fail to pick up after their dogs may be excused.**

Running order:

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. Master will be run in blinds of four dogs; all other classes in blinds of five. **All requests for running order changes must be approved by the Trial Committee.**

Awards:

Strip ribbons will be awarded for First through Fourth place in Novice through Master classes in each height division. Strip ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. High in Class rosettes will be offered for the fastest qualifying dog in each class in each trial. New Title rosettes will also be awarded.

Various special awards may also be presented; for fastest qualifying run, oldest dog to qualify, etc. over several different breeds and breed types. See the confirmation email for more information. These will be awarded after the end of Trial 1 on Sunday - you must be present to receive a special award; they will not be mailed.

If you are up for a RATCH or RATCHX, please inform the Trial Secretary before the closing date.

Please bring adequate food and water for your dogs. There are several fast-food restaurants nearby. There are indoor restrooms on site.

B Level Classes Are Here!

B level classes are now available. See the rule book for details, but here are a couple of key things to note when sending in your entry form:

1. You MUST check either A or B (not both) on the entry form.
2. If you enter your dog in B classes you MUST enter him or her in the same level class for the entire event.
3. If you earn a title in an A level class at an event you can move up to the next level A class or laterally to the same level B class. You cannot move down to a lower-level B class at an event.
4. For those competing in the Master class, once you have earned your RATM title you MUST enter trials in B classes. You can enter any level of B class but must stay at that level for the entire event. All RATCH and above titles are earned in B classes.

Team!

Team will be offered after the end of the day on Saturday, time permitting. This is a non-titling, for-exhibition-only class. Team is a fun game involving two dogs hunting in the same ring that is played at the Barn Hunt National. All proceeds from Team will be added to a fund we have set aside to benefit rat and dog charities, or to help Barn Hunt people who find themselves in need due to sudden veterinary or weather issues, or to other worthy causes.

The rules for Team and any additional details will be described at the event and in your confirmation email.
